

Challenges in land administration hinder economic development.






- Analyze the importance of effective land administration in nurturing its significance society growth and development.



- ✓ a citizens' assembly which gives people an opportunity to meet with members of the municipal council and review progress on electoral promises; or
- ✓ small neighbourhood meetings to share information, identify problems and propose solutions.

The stages of the Land Strategic Planning Process:

Below are the developed stages that would promote effective community driven land administration.

Stage 1: Prompting and Stakeholder Engagement in Land ownership of inferior interest or informal land holdings.

- 1. Define the land area: Identify the geographic area of the Land ownership of inferior interest or informal land holdings. Thereafter, get the open source google real-time maps.
- 2. Establish the land capturing team: Assemble a team of stakeholders, including landowners, community members, and government agencies.
- 3. Identify stakeholder interests: Determine the interests and concerns of each stakeholder group.

Stage 2: Situation Analysis and Data Collection

- 1. Gather data: Collect data on land use, demographics, economy, infrastructure, and environmental factors.
- 2. Analyze data: Analyze the data to identify trends, patterns, land boundaries and relationships.
- 3. Identify key issues: Determine the key issues and opportunities related to land use and management.

Stage 3: Targets and Goal Setting

- 1. Develop a vision statement: Create a vision statement that outlines the desired future for the land.
- 2. Establish goals and objectives: Set specific, measurable, achievable, relevant, and time-bound (SMART) goals and objectives for land use and management.
- 3. Identify key performance indicators (KPIs): Develop KPIs to measure progress toward achieving the goals and objectives.

Stage 4: Land Use Analysis and Scenario Development

- 1. Analyze land use patterns: Examine existing land use patterns and identify opportunities for change.
- 2. Develop alternative scenarios: Create alternative scenarios for land use and management.
- 3. Evaluate scenarios: Assess the potential impacts and benefits of each scenario.
- 4. Establish Boundary Alternative Disputes Resolutions Mechanism Know your land boundaries owners and identify limits and size of holdings on google maps.

Stage 5: Strategy Development and Selection

- 1. Develop a preferred scenario: Select a preferred scenario based on the evaluation of alternative scenarios.
- 2. Develop a land holdings strategic plan: Create a land strategic plan that outlines the steps needed to implement the preferred scenario.
- 3. Establish a budget and timeline: Determine the budget and timeline required to implement the strategic plan that would lead to simplification of other land interest certification accepted and recognised besides C oF O.

Stage 6: Implementation and Monitoring

- 1. Implement the land strategic plan: Carry out the actions outlined in the land strategic plan.
- 2. Monitor progress: Track progress toward achieving the goals and objectives.
- 3. Evaluate effectiveness: Assess the effectiveness of the land strategic plan and make adjustments as needed and where necessary.

Stage 7: Review and Revision

- 1. Review the land strategic plan: Regularly review the land strategic plan to ensure it remains relevant and effective to community needs.
- 2. Revise the land strategic plan: Revise the land strategic plan as needed to reflect changes in circumstances or new information according to the dynamics of time and community perspective.

Land Policy and Legislative Framework advocated.

- 1. Promote and encourage the Enactment of land reform laws that recognize and protect community land rights.
- 2. Develop a national land policy that prioritizes community-driven approaches to land administration.
- 3. formulate and implement institutional reforms to ensure that land administration institutions are more inclusive, transparent, and accountable.

Implementation Strategies

- 1. Encourage and Implement pilot projects to test community-driven approaches to land administration.
- 2. Build the capacity of local communities, government officials, and other stakeholders to support community-driven approaches in land administration and management.
- 3. Foster partnerships between government, civil society, and private sector organizations to support community-driven approaches in transforming land administration and management in Nigeria.
- 4. Establish monitoring and evaluation frameworks to assess the effectiveness of community-driven approaches in land administration.
