- Fraud prevention: Eliminates document forgery and unauthorized modifications.

#### 2.2.1 Case Study: Georgia's Blockchain-Based Land Registry

Georgia implemented a blockchain-based land registry in 2016, reducing transaction times by 90% and eliminating fraudulent claims (World Bank, 2022).
