

## OUTLINE



Land, as an important factor of production has become a major issue of contention, and ultimate source of wealth (UN-ECE, 1996).

The right to land has been considered as a major component in the economic development.

☐ A good system for land registration has effect on the socio-economic development of a country (UN-FIG, 1999).





- Globally, no country has developed without undertaking land administration reform, which has become imperative to every country of the world towards achieving 2030 SDGs.
- ➤ Unfortunately, Africa is far behind in the paradigm shift in land administration within the context of the geospatial technology advancement in the world:



- ✓ to know what is where?
- ✓ who is where?
- who owns what in determining rights of individual as pertaining to land?

Land without proper title deeds remains "dead capital" both to the government and the people and thus contribute to poverty, as it:

☐In Africa, most people own land through informal procedure ("Without legal title") and few processed title deed to C of O point. (formal procedure "Legally").
☐ The existing land policy and land Acts in most countries including Nigeria locks up the potential and benefits which land should provide for the people.
☐ About 900,000 square kilometres of Nigerian Land is effectively lock up as "Dead Capital".
☐ It is not possible to fully harness the potentials in land and land resources without title deeds (Atilola, 2013).
☐ Unlocking the potential in land starts with proper land titling and registration.

### LAND REGISTRATION AND 2030 SDGs

The key questions in land tenure are:

Who holds the land OWNER (individual or group)? RIGHT (TITLE) HOW? leasehold, etc.)? WHERE/HOW **PAECELS** MUCH?

How is it held (ownership,

Their relationship brings about a system of land registration.

Where is it located (specific parcel)?

### LAND REGISTRATION AND 2030 SDGs


- Many countries of Africa do not have a well-functioning system of land registration.
- ➤ It evolves through quasi land tenure systems which do not guarantee the right of every individual
- ➤ Under five SDGs 1, 2, 5, 11 and 15 (UN, 2020) there are 10 land-related targets and 12 indicators to ensure prosperity for all and healthy environment.



Achieving the 2030 Sustainable Development Goals (SDGs) which is directly tied to land may be difficult with sporadic system of land registration.

#### AN OVERVIEW OF LAND LAWS IN NIGERIA

- ☐ In Nigeria, land laws have witnessed different epochs in its development
- ☐ Sporadic method of land registration was the practice adopted in Nigeria
- Less than 5% land in Nigeria has been registered (PTCLR 2013)



## SYSTEMATIC LAND TITLING AND REGISTRATION (SLTR) AS A FIT-FOR-PURPOSE APPROACH

The term "Fit-for-Purpose (FFP) means applying the spatial, legal and institutional methodologies that best suit tl

Systematic land titling and registration (SLTR) is a prototype of FFP land administration

SLTR is a process by which rights to land in a particular area are ascertained and then documented in an official register of land titles (PTCLR, 2014).

## SYSTEMATIC LAND TITLING AND REGISTRATION IN NIGERIA

The SLTR will include four (4) main interrelated components



Capturing, revalidation, and updating of cadastral land registration

For instance, during pilot project, about 14,600 parcels were captured in three selected LGA in Ondo State

#### SYSTEMATIC LAND TITLING AND REGISTRATION IN NIGERIA

Unlocking Dead Capital is achievable through Cadastral Information System (CIS) based on SLTR.

To account for every square metres of land in the nation.



To harness land and land resources potentials for the prosperity of residents and businesses in Nigeria

SLTR will incorporate land acquisition, land titling and registration for integration in a digital database.

☐ There are a number of available tools which are suitable for adaptation within the Nigeria context.


☐ GLTN and FIG advocate for the application of sustainable tools and approaches for better land administration and information (GLTN, 2016; Hendriksa, et al., 2019).

Two of these tools are particularly relevant, these are:

- 1. Social Tenure Domain Model (STDM) developed by GLTN
- 2. Solution for Open Land Administration (SOLA) developed by FAO

## RELEVANT SOFTWARE FOR SUSTAINABLE LAND INFORMATION SYSTEM (LIS)

The STDM explains the interrelationship between parties, social tenure, and the spatial units supported by relevant documents (UN-Habitat/GLTN, 2016).

### 2. Solution for Open Land Administration (SOLA)

The aims of formulating SOLA are to computerize cadastre and registration systems in affordable and sustainable manners with the main focus on developing countries.

- In ascertaining the effectiveness of SOLA, the pilot project was initiated in Ghana, Nepal and Samoa, and later extended to Lesotho.
- It was also used in systematic land titling and registration work in Ondo, Kaduna, Kano and Kogi States (Nigeria).

### Is Nigeria Ready for Land Reform?

• Are there enabling environment and political will for the paradigm shift?

#### COST RECOVERY SYSTEM FOR LAND ADMINISTRATION SERVICES

- ☐ there is a decision supporting tool called Costing and Financing of Land Administration Services (CoFLAS), involving four stages.

The stakeholders needs to give strong support to the proposed Land Use Acts Regulation (2013) by PTCLR

• A paradigm shift from Sporadic to SLTR land registration system remains a panacea for a better land reform that will unlock the dead capital in land resources and enhance prosperity for all states in Nigeria.
